- Knights of Columbus thanked us for our donation to their annual outing at knickerbocker golf course.

Finance report: 412 Rounds for January. Not the best January on record. Restaurant rent paid. Anthony situated the online membership renewal for members to renew through website. Increase in membership signups compared to previous years. Lottery and league signups began.

General Manager / Superintendent Report

- Tree work continued throughout course.
- Ground is frozen, mined soil out of pond on 8.
- Rebuilt tee on 8 with quality soil dug in church property we purchased.
- Rain shelter removal went along pretty well. Lumber will be used to make bird and bat houses to control bugs across the property.
- Maintenance staff is generating the Borough additional income through use of our reel grinding equipment to service for other golf courses equipment.
- We will have an excess of material from pond project that will be utilized around the course to enhance features and increase player safety. Updated map will be provided.
- Course will be looking further into the use of autonomous equipment.
Superintendent conference held a seminar which brought more insight into the future direction of the equipment and how it can be best utilized on our golf course.

- Lights and music left on at restaurant consistently. Rent and utilities not yet paid for Feb.

New Business:

- Steve: Golf simulator bid is ready and clerk has bid package drafted. Resolution to advertise for bid on golf simulator was passed at Mayor & Council meeting.
- Steve: Reviewed each page of bid package details. Goal is at least 5 bidders. Hoping to be under construction in late spring.
- Window for mini golf service and a retractable door was discussed to be added on right side area of new simulator building.
- Trophies would be great to hand out at the lottery by Mayor and Council. Great opportunity with 300 golfers attending.
- Discussion about cell tower on property to improve service. Andy will discuss with Borough Administrator.
- Andy: Passed around 2025 fiscal budget as requested from previous meeting. Reviewed and discussed each category. Reviewed bonded and capital outlay funded old business discussed-projects.
- Steve point of information: Money borough holds in bonds, upon six years, where's the interest that the borough has been enjoying go? Andy: we don't know, not visible on our reports.
- Steve point of information: Asked about credit card fee's budgeted vs spent and why such a large difference. Andy/Anthony: We are looking into it, our system indicated much differently.
- Sean: PGA Hope will continue as it did previous year. Will be instituting a PGA junior league. It's a different type of format where we give lessons, but then also the kids play in a scramble format and another introduction to try to get more kids here on the property. Registrants are age 13 and under, recruited and paid through the PGA along with ourselves. 14-17 age groups will be included too, more information will follow.
- Sunrise Rotary inquired about their annual outing in May.
